"High Cost Drugs:

How Did We Get Here and Where Do We Go Now?"

Please join us for the PRN's 2017 Focus Session on Sunday October 8th, 4 – 5:30pm. The PRN's Annual Meeting Planning Committee has been working hard since last fall to ensure that our focus session at the 2017 Annual Meeting is informative and interesting.

The purpose of this focus session is to identify the different contributors to the high cost of drugs that limit the patient's ability to acquire needed medications and for care settings to justify an equitable method to provide these medications. Attendees will be presented with process management plans, communication approaches for the C-Suite, contextual examples and algorithms to consider for mitigation of high cost drugs in their organizations. The target audience includes healthcare professionals in various care settings including but not limited to staff and clinical pharmacists, clinical and pharmacy operation managers, pharmacy directors and hospital and pharmacy administrators.

The focus session has an impressive group of speakers:



Lee C. Vermeulen, Jr. B.S.Pharm, MS, FCCP, FFIP

Mr. Vermeulen will describe factors that have contributed to the increase in cost of pharmaceuticals and he will describe the role of manufacturer's pricing policies on overall expenditure patterns. He will also explore potential future trends related to pricing.



Karen J. McConnell PharmD, FCCP, ASH-CHC BCPS-AQ Cardiology

Dr. McConnell will discuss how to develop an interdisciplinary cost-containment team. She will describe how to develop and implement operational and clinical cost-containment strategies. She will explain how to assess cost-containment strategy outcomes.



Melissa Skelton Duke PharmD, MS, BCPS

Dr. Duke will review patient focused strategies that include the topic of high cost drugs in the ambulatory setting. She will describe governmental and pharmacy programs relevant to patients in the ambulatory setting. She will identify key high cost drugs used in ambulatory care and strategies to ensure their appropriate use.

Communications Committee Updates

Student & Resident Travel Awards

The Clinical Administration PRN is in their third year of offering travel awards to aid students and residents travelling to the ACCP Annual Meeting. The PRN is especially interested in supporting students and residents that are focusing their education and training in pharmacy administration or pharmacy informatics.

Awards of \$750 and \$1000 will be awarded to two students and one resident, respectively. To be eligible to apply for the travel award, the candidate must:

- Be a full time student/resident/ fellow member of ACCP in good standing
- 2) Be a member of the Clinical Administration PRN
- Be currently enrolled in an administration residency program (PGY1 or PGY2) OR a resident/ student/fellow that has demonstrated significant progress in a pharmacy administration project.
- Be committed to attending the ACCP Annual Meeting and Clinical Administration PRN Business Meeting, where the candidate will present their administration project.

The application and accompanying documents (CV, personal statement and description of project) must be submitted to Cindy Brasher (Cindy.Brasher@msj.org) by August 15, 2017 at 11:59 EST. An email will be going out soon with the application. Award selections will be announced prior to the Early Bird Registration Deadline for the meeting.



Clinical Administration PRN Travel Award Application

The Clinical Administration PRN will award 3 travel grants to qualifying applicants that are attending the 2017 ACCP Annual Meeting in Hollywood, Florida in order to provide partial financial support.

- Student travel award (2): \$750
- Resident travel award (1): \$1000

Applicants must meet the following criteria:

- 1. Be a full time student/resident member of ACCP in good standing
- 2. Be a member of the Clinical Administration PRN
- 3. Currently enrolled in an administration residency program (PGY1 or PGY2) OR a resident/student that has demonstrated significant progress in a pharmacy administration project.
- 4. Be committed to attending the ACCP Annual Meeting and Clinical Administration PRN Business Meeting, where the candidate will present their administration project.
- **All applicants will be expected to obtain a signature of their current primary preceptor/faculty advisor or program director to ensure awareness of their travel intentions.

Materials for Submission

- 1) The Travel Award Application form
- 2) Curriculum Vitae
- 3) A personal statement (500 words or less) highlighting the following:
 - A description of the project you intend to present at the Clinical Administration PRN Business Meeting
 - Your involvement in pharmacy administration/informatics at a local or national level (including involvement with the Clinical Administration PRN)
 - How you will benefit from your time at the ACCP Annual Meeting
 - Interest in future involvement with ACCP and/or the Clinical Administration PRN
