SUMMARY

A survey was conducted among a large and diverse practicing pharmacist population of metrics for clinical pharmacy productivity. There are many different metrics and tracking systems used with no clear consensus. While there are many perceived benefits, there are also many perceived barriers. It was recommended to develop a standardized approach.

A cost comparison was conducted for patients being discharged from hospitals. The control group received no clinical pharmacy services. The basic intervention received a pharmacist review of discharge orders. The extensive intervention group received pharmacist review, medication education, and a post-discharge meeting with the pharmacist. While program cost for both intervention groups was more than the control group, extensive intervention was associated with a significant overall resource utilization decrease, mostly due to decreased emergency care and readmissions.

Compounding of custom dosage forms for patients is an important part of pharmacy practice. There are some therapeutic areas, for example, pain management and hormone replacement, in which compounded dosage forms have become common and popular. There are concerns related to safety, lack of efficacy, poorly regulated promotion of products, and complex reimbursement systems.
