#### Nitish Bangalore, PharmD, BCPS:

## **Member Focus**

This month we are highlighting **Tanvi Patil**, PharmD, BCPS, CPP, PGY1 Pharmacy Residency Director, Associate Chief of Pharmacy, Clinical Services and Education, Clinical Pharmacy Specialist-Cardiology, SALEM VAMC who is the MERIT scholarship recipient for the 2022 CADM PRN. We discussed several different topics relating to MERIT and her career.

- How has being a MERIT scholarship recipient helped you grow personally and professionally?
  - Being able to receive MERIT scholarship from both Cardiology PRN and CADM PRN has really helped me afford this amazing opportunity to grow my research and scholarship career further as well as expand on my pharmacy network. I was able to attend the live training part this past summer June 2022, at University of Kentucky. Being a scholarship recipient also helped me obtain additional assistance from my employer towards travel for the live summer training as well to present poster in October ACCP Global Conference meeting.
- 2. What is one thing you have learned as a MERIT scholarship recipient that you can share with everyone to help them grow professionally and personally?
  - I think one of the most amazing things for me was to learn different career paths each instructor/mentor had taken to be in their current role and ability to connect with them one on one. While learning some of the different types of research was enlightening, for me understanding these possibilities helped broaden my understanding of what can be achieved as a pharmacist. This has helped me ponder on the next phase of my career as I complete 10 years of professional pharmacy

practice experience this year and get clarity on how I could use research and scholarship to shape the remainder of it.

- 3. What have you used the MERIT scholarship for with respect to practice?
  - I used the MERIT scholarship towards the tuition for the MERIT program. As Pharmacist in a non-academic world, without this assistance, it would have been impossible for me to go through the MERIT program. I am, therefore, very grateful for the support ACCP PRNs provide for pharmacist members to enable them to take advantage of such a great program.
- 4. What is the most rewarding experience of being a practitioner, especially in your current role?
  - In my currently role, I wear a variety of hats from being a supervisor, residency program director to clinical pharmacy practitioner in outpatient cardiology clinic. One of the most rewarding experience of maintaining my clinical practice is the impact I can make by optimizing GDMT for heart failure patient as advanced provider with scope of practice. When I see my patients progressively improving both objectively but more so in terms of their quality of life, such as they can breathe better, walk more, go fishing and enjoy the things they could not before, I get immense joy. It makes what I do more meaningful and fulfilling.
- 5. What are your future plans in your professional career?
  - Honestly, I hadn't been very intentional about my career and as opportunities came by, I explored them by being present and dedicating myself towards it. However, one thing that I always enjoyed is research and I hope that I can grow my career such that I can still incorporate research even in the future. I enjoy my current role that

#### **CADM PRN Focus Session:**

We are proud to present "Fundamentals of the Pharmacy Workforce: Basics We Neglected During the Pandemic" as our **focus session** at the 2022 Global Conference on Clinical Pharmacy. The program will be held **Sunday**, **October 16**, **2:15-3:45 pm**. The purpose of the program is to review core principles for developing and maintaining an exceptional pharmacy workforce. Specific topics will include:

- 1. Recruitment Strategies for successful recruitment of clinical pharmacists and other members of the pharmacy department. Specific topics include writing job summaries for online postings, interview questions, candidate selection, and identification of interviewers.
- 2. On-boarding new staff Development of checklists and competencies that are critical to orient and train new staff. Measures of success

of an on-boarding program include reduced turnover and increased staff engagement.

3. Succession planning – A framework for identifying and developing talent and leadership from within a current pharmacy department. Successful succession planning allows for seamless transitions as leaders leave an organization. This also allows for resiliency for unexpected leaves or departures. This includes strategic recruitment of talent, purposeful onboarding, and planning for leadership turnover.
